No. SO(HR)LD/2-3/DGHR/NGR/2024-25/Vol-X: In exercise of the powers conferred by section 13 of the Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights Act, 2014 (Khyber Pakhtunkhwa Act No. III of 2014), read with section 7 thereof, the Government of Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Non-Governmental Organizations Registration (Working in the Field of Human Rights) Rules, 2024, the following amendments shall be made, namely:

AMENDMENTS

- 1. In rule 3,-
 - (i) in sub-rule (3), for the words, figure and brackets "ten percent (10%)", the words, figure and brackets "five percent (5%)" shall be substituted; and
 - (ii) in sub-rule (4),-
 - (a) in clause (a), for the words "a scheduled bank", the words "Government treasury" shall be substituted;
 - (b) in clause (c), for the words "general meeting of the members", the words "Executive Board meeting" shall be substituted;
 - (c) for clause (d), the following shall be substituted, namely:
 - "(d) a report of activities for the last three years or since the establishment of Non-Governmental Organization, whichever is less or a state of activities, undertaken during the said period:

Provided that this condition shall apply to existing Non-Governmental Organizations and shall not be applicable to the Non-Governmental Organizations to be newly established;";

- (d) clause (f) shall be deleted; and
- (e) for sub-rule (6), the following shall be substituted, namely:

"(6) In case the applicant fails to fulfill the deficiency within the time specified by the Directorate General, the time for fulfilling the deficiency may be extended for such period as may be determined by the Directorate General. In case the applicant fails to fulfill the deficiency within the extended time, his application may be rejected by the Director General by an order in writing.".



The existing provision of rule 4 shall be numbered as sub-rule (1) of rule 4 and after sub-rule (1) as so numbered, the following new sub-rules shall be added, namely:

"(2) The Non-Governmental Organization after getting registered under sub-rule (1), shall register itself with the Charitable Commission within six months from the date of registration with the Directorate General. The Non-Governmental Organization shall provide a copy of the registration certificate issued by the Charity Commission to the Directorate General forthwith.

(3) If the Non-Governmental Organization fails to furnish the registration certificate issued by the Charitable Commission, the Director General shall issue a notice to the Non-Governmental Organization to furnish the registration certificate within such time not exceeding sixty days. If the Non-Governmental Organization still fails to furnish the certificate, the Director General may, after giving the Non-Governmental Organization an opportunity of hearing, suspend the registration of the Non-Governmental Organization by an order in writing till the time the Non-Governmental Organization furnishes registration certificate issued by the Charitable Commission.".

- 3. In rule 7, sub-rule (2) shall be deleted.
- 4. In rule 10,-
 - (a) in sub-rule (2), after the words "if needed", the words "and in consultation with the concerned registered Non-Governmental Organization" shall be inserted; and
 - (b) in sub-rule (5), after the words "operation or activity", the words "regarding promotion and protection of human rights" shall be inserted.

5. After rule 11, the following new rule shall be added, namely:

"12. Power to amend Schedule.---The Department may amend the Schedule from time to time.".

6. For Schedule-I, the following shall be substituted, namely:
